**TRADITIONAL:** Resemble scarecrows found in fields/gardens for centuries (Open to all).

**WHIMSICAL:** Whimsical character(s) made of any material (Open to all).

**COMMERCIAL:** Open to "for-profit" businesses

## IMPORTANT INFORMATION & CONTEST RULES

### ENTRIES

- All entries must be completed, checked-in and on display by 5:00p.m. on Friday, October 17<sup>th</sup> 2008
- All entries receive a 4'x 4' foot area. Larger spaces are available upon request
  - Multiple Scarecrows may be displayed in the 4'x 4' area.
- One entry per category per person, family, business, or organization.
  - Entries in multiple categories are permitted.

### THEME

- Scarecrow(s) for display may reflect a "special" theme and/or promote a company or organization.
  - Scarecrows do not have to be traditional, we encourage you to be CREATIVE.
  - Scarecrows must be in good taste & constructed to withstand the weather.
- Scarecrows reflecting controversial, social, religious or political opinions or statements will not be accepted. Fall Fest Agents reserves the right to remove any scarecrow it deems inappropriate.

### DESIGN

- Scarecrow entries/designs must be NEW each year and weather proof.
- Review the rules of each category before submitting the entry form. The Fall Fest Agents reserves the right to change the category if the scarecrow does not meet the criteria of submitted category.
  - No items such as tiki torches or gas-powered generators allowed.

### SIGNAGE

- Signs may be placed at your display to announce your scarecrow's name.
  - Business and Organization names are allowed
- Detailed check in, setup, and tear down information will be sent to the email address provided on the entry form approximately one week from receipt by the Fall Fest Agents.
